\$60.00 after August 19<sup>th</sup>. Entries will be accepted up to the day of the event.  
Dressage times are limited, and will be scheduled on a first come basis. One dressage ride per entry please. There will be no refunds if you do not get to ride a dressage test.

Your entry fee includes:

- ❖ Access to the grounds from 10am-4pm (grounds open at 9am, but no jumping or cross country riding will be allowed before 10am).
- ❖ Ability to ride stadium rounds, heights will be adjusted throughout the day.
- ❖ Ability to ride the track of a future cross country course. A limited amount of jumps will be on course.
- ❖ Access to miles of groomed trails.
- ❖ Ability to school on an obstacle course, including a large water obstacle.
- ❖ Ability to ride a dressage test of your choice. Space is limited.
- ❖ Ability to ride in "Suitable for Dressage" flat classes in the indoor. Classes will be at 11am, 1pm, and 3pm sharp. Ribbons will be awarded for flat classes.

Notes: **NO DOGS ON THE GROUNDS PLEASE.**

Snacks and drinks will be available for purchase.
